#### Introduction

In accordance with the provisions of the Local Government Act 1991 (Regional Assemblies) (Establishment) Order 2014, I present the third annual programme of work to the elected members of the Assembly for approval.

During this year the substantive policy development element of the Assemblies remit, the production of Regional Spatial and Economic Strategies, will commence. This programme sets out the actions that consolidate the Assembly as an important contributor to, and leader of, the planning and economic development of the region. It also retains the focus on continued improvement of the region's participation in EU activities and governance. In 2015 members approved our Corporate Plan and this programme of work relates directly to its objectives and contains actions that will deliver upon its stated ethos.

As in previous programmes of work, quarterly progress reports will be issued where specific actions relating to the work item and timeline will enable members to monitor progress and assess the effectiveness of the Assembly. In a modification to previous plans, this iteration focusses on the key headline areas as identified in the Corporate Plan and integrates the Assemblies activities across these headings. This will assist in maintaining a focus on policy and will help with the important role the Assembly plays in promoting participation by the 12 Local Authorities in EU related activities, with the ultimate goal of funding following policy.

This year holds a number of key objectives such as the delivery of the Regional Spatial and Economic Strategies, participation in the National Planning Framework process, continuing to strengthen Strategic Planning Areas and participation in the implementation and monitoring of the Regional Action Plan for Jobs, the Action Plan for Rural Development and other national policy initiatives. Along with the ongoing monitoring of county and city Development Plans and Local Economic Community Plans this substantial workload will require adequate resources, and the resourcing of the Assembly is a priority. Participation within EU activities from a governance and project participation perspective also requires experience and expertise and I will recruit, train and maintain the administration resource required to provide members and stakeholders with a first class service. The activities of the Irish Regions Office in Brussels and of our Programme Executive team will underpin our EU participation.

The provision of training and information to members is also of key importance to the effective performance of the Assembly and throughout the year information presentations, seminars, workshops and conferences will be held to further members' participation in the wide range of activities with which the Assembly is involved.

I look forward to continuing the close collaboration with the Assembly members during the year ahead and I am confident that the programme of work set out for your approval will see 2017 continue with Eastern and Midland Regional Assembly at the forefront of regional economic growth, sustainable planning and EU activities.
