#### ITEM 1

#### **Election of Cathaoirleach**

Cllr K Feeney was elected An Cathaoirleach for the Eastern and Midland Regional Assembly with no other nominations received.

This was AGREED.

#### ITEM 2

#### ITEM 3

#### Adoption of Minutes of meeting held on 9th June 2023

The presentation covered the context; the public bodies and local authorities contacted; the progress made and conclusions and recommendations.

Following a contribution from CIIr D Healy, it was agreed that a letter be issued to the CCMA with regard to the Climate Action Regional Offices (CAROs).

Cllr P Mc Evoy proposed that a letter is issued to NOAC. Cllr K Feeney seconded this proposal and added that the Assembly also writes to the Planning spokespersons of Dáil and Seanad Éireann.
