#### ITEM 1

#### Adoption of Minutes of meeting held on 8th December 2023.

#### ITEM 2

Presentation of the report on the Monitoring of the application of the European Charter of Local Self-Government.

Vladimir Prebilič, co-rapporteur, presented the report on the Monitoring of the application of the European Charter of Local Self-Government in Ireland. His presentation included a snapshot of the situation in Ireland and its evolution since the last report; the positive changes; the remaining causes for concern; the recommendations of the report and the conclusions.

A discussion followed with contributions from Cllr D Lacey, Cllr C Keelan Cllr D Meenagh, Cllr D Heney, Cllr J Gildea, Cllr D Healy, Cllr D Gilroy, Cllr K Feeney, and Cllr P McEvoy.

An Cathaoirleach K Feeney proposed that the Assembly writes to Minister K O'Donnell to engage with him on the findings of the report.

This was AGREED.

#### ITEM 3

#### **Planning Items**

i) Draft EMRA submission on the Fingal LECP (for Adoption)

Ms AM Wood Wolfe presented the Draft EMRA Submission on the Fingal LECP.

Cllr D Healy proposed that the wording "The final LECP should include an action, possibly in the Implementation Plan, to apply sustainability analysis that captures the three key principles of the RSES- climate action, health placemaking and economic opportunity to inform actions across the Plan and consider the principles of 'Doughnut Economics', especially under Theme 2 Prosperous Economy", be included in this submission and this was seconded by Cllr P McEvoy.

A discussion followed with contributions from Cllr D Healy, Cllr B Manton, Cllr J Gildea, Cllr A Gilliland, Cllr D Lacey, Cllr D Heney, Cllr P McEvoy, Ms J Martin, Cllr D Gilroy, Cllr C Keelan, Ms AM Wood Wolfe, and Ms C Bannon.

A vote on the above proposal was taken. Cllr A Gilliland, Cllr D Gilroy, Cllr L Hagin Meade, Cllr D Healy, Cllr J Horner, Cllr P McEvoy, Cllr D Meenagh, and Cllr P O'Brien voted for the amended wording.

Cllr J Browne, Cllr E Coffey, Cllr K Feeney, Cllr C Fitzgerald, Cllr E Fitzpatrick, Cllr J Gildea, Cllr D Heney, Cllr C Keelan, Cllr B Manton, Cllr J Moylan, Cllr C Murray, and Cllr G Walsh voted against the proposal.

Cllr E Blain, Cllr F Brett, Cllr D Lacey, and Cllr P Meade abstained from the vote.

With 8 votes for, 12 against and 4 abstentions, the proposed amendment was rejected.

The draft EMRA submission on the Fingal LECP as presented was proposed by Cllr B Manton and seconded by Cllr J Gildea.

This was APRROVED.

Draft letter to the planning spokespersons of the Dáil and the Seanad re the Planning and Development Bill 2023

Acting Assistant Director and Senior Planner AM Wood Wolfe presented the draft letter to planning spokesperson in the Dáil and Seanad Éireann regarding the Planning and Development Bill 2023.
