#### ITEM 1

## Adoption of Minutes held on 13th November 2015

Minutes of meeting of the Eastern and Midland Regional Assembly held on the 13<sup>th</sup> November 2015 were proposed by Councillor Padraig McEvoy and seconded by Councillor Paddy Bourke. The Minutes were **APPROVED** and **ADOPTED**.

#### ITEM 2

#### **1916 Commemorations**

Presentation by Mr. Michael O'Reilly

Mr. O'Reilly presented the programme for the 1916 Commemorations.

The presentation focused on the following areas:

- Overarching purpose
- National Flag
- Seven programme Strands
- Intergenerational Learning
- Global and Diaspora

A discussion took place around the celebrations being held to mark the centenary with contributions from Cllr S. Bourke and the Cathaoirleach. The Cathaoirleach and the Director thanked Mr. O'Reilly for presenting to the Assembly.

#### ITEM 3

#### Irish Water

#### Presentation by Mr. Gerry Geoghegan

Gerry Geoghegan presented the Water Supply project for the Eastern and Midland Region to the Assembly including the Preliminary Options Appraisals Report.

- Project Roadmap
- Preliminary Options Appraisal Report
- Community Gain
- Landowner Engagement
- Final Options Appraisal Report
- Background Project need

A discussion took place with contributions from all Councillors present regarding the preferred options including alternative routes, the option for storage at a site, in light of current issues with flooding on the Shannon, treatment of water from the Shannon and CPOs and wayleaves on landowners. Mr Geoghegan and his colleague Mr. Mick Garry clarified the issues raised in relation to the preferred option, treatment and other queries raised.

#### ITEM 4

#### **Planning Items**

Submission on Draft Dublin City Development Plan 2017-2023.

An outline of the submission was presented by Mr. Malachy Bradley.

The following Councillors contributed to the discussion Cllrs B. Fitzgerald, K. Dennison, D. Lacey, and Cathaoirleach P. Vance. After the discussion the submission was proposed by Cllr Dermot Lacey and seconded by Cllr. Padraig McEvoy. The submission was **APPROVED** and **ADOPTED**.

#### ITEM 5

#### **Local Economic and Community Plans**

Draft Kildare County Council LECP and statement on the plan was circulated to members for their consideration.

Mr. Malachy Bradly outlined that the Kildare County Council LECP was consistent with the Core Strategy and County Development Plan objectives, with the Regional Planning Guidelines and between the community and economic elements of the plan.

The Kildare County Council Draft LECP statement was APPROVED.

#### ITEM 6

#### **Committee of Regions update**

Cllr. Mary Freehill gave an update on the plenary session of the Committee of the Regions that took place last week which had a large focus on migrants.

Cllr Kate Feeney thanked Cllr Freehill for her time as Head of Irish Delegation and good luck to Cllr. Neale Richmond who is taking up the post.

Cllr. Horkan and Lacey added thanks to Cllr. Freehill and best wishes to Cllr. Richmond.

#### ITEM 7

#### **Schedule of Meetings**

A schedule of meetings was distributed for 2016. The schedule was APPROVED.

#### ITEM 8

#### Correspondence

The Director explained that he had made attempts to contact Cllr. King and under SI 573 of 2014 states:

"A person shall be deemed to have resigned from membership of a regional assembly where a person is absent from attendance at any meeting of the assembly for a continuous period of 6 consecutive months from the date of his or her last attendance"

The correspondence was **NOTED**.

#### ITEM 9

#### **Any Other Business**

A discussion around attendance took place with contributions from Cllrs Dennison, Horkan, Freehill, McEvoy Lacey and Cathaoirleach Vance. Members requested that attendance at Eastern and Midland Regional Assembly and Committee of the Regions be listed. They also requested quarterly reports for their local authorities.

Cllr Horkan thanked Cathaoirleach, Members and staff of the regional assembly for the work done in 2015.

A discussion arose around the Minister setting up a review committee for county boundaries in Louth/Meath, Cllrs B. Fitzgerald, Lacey, Horkan and Cathaoirleach Vance contributed. It was agreed to write to Minister that the Regional Assembly should be part of the consultative process and notified in the case of proposed boundary changes. **AGREED.** 

An Cathaoirleach reflected on the achievements of the Assembly during the year and thanked the members, designated Chief Executives, Staff and all who had contributed to its work. He wished everyone seasonal good wishes.
