ITEM 1

Election of Cathaoirleach & Leas Cathaoirleach

Councillor Fiona O'Loughlin, proposed that Councillor Pat Vance be elected Cathaoirleach for the coming year and this proposal was seconded by Councillor Tommy Reilly.

ITEM 3

Presentation by National Transport Authority

- Presentation by Anne Graham

Ms Anne O'Dwyer introduced the role and functions of the National Transport Authority. The presentation covered the following topics:

- National Trends in Travel
- The Challenges and Solutions
- Travel Management
- Rural Transport
- Draft Transport strategy for the Greater Dublin Area
- Integrated Implementation Plan 2013-2018

Following the presentation, the following issues arising from the report were raised by the following members, Councillors E Fitzpatrick, L McCarthy, F O'Loughlin, G Horkan, P McEvoy, F Duffy, D Lacey, C Fitzgerald, K Dennison, T. Byrne, B. McDonagh, M. Murphy, S Bourke, I Keatley, M Freehill, and P Vance.

The contributions raised questions and concerns around the following transportation topics, rural transportation options, bus shelters, rail ticket pricing in commuter belts, suitable bicycle parking in the city centre, M50 tolling, car parking in rail stations, the Metro North recommendation, planning densities around transport hubs and the design of cycle lanes. Anne O Dwyer and Hugh Creegan from NTA addressed all the issues raised from the members on the above topics.

The Cathaoirleach thanked the representatives from the NTA for their presentation.

ITEM 4 - Planning items

Eirgrid North-South Interconnection Development

A draft submission was circulated to the Members with regard to the proposed development by Eirgrid of a North-South Interconnection Mr. Bradley presented an outline of the draft submission and informed the members that the submission was being made to An Bord Pleanála under the Strategic Infrastructure Development Application Process. The submission was being recommended to the members as this development proposal is supported in RPG policy.

There followed a discussion on the submission with contributions from Cllrs Keatly, McEvoy, C. Fitzgerald, B. Fitzgerald, M. Murphy. Following this discussion it was AGREED to insert the following into the submission to reflect the members concerns on the development proposals as they stand.

"In this regard the relevant policy document – The Regional Planning Guidelines for the Greater Dublin Area (which includes Meath) supports the principle of a North-South Electricity supply Interconnection. However the Members of the Regional Assembly have significant concerns with the proposals as presented. The impact of the proposed pylons on health, agriculture, one off housing and landscape; and the lack of proposals to underground the lines are issues that the Members state should be taken into consideration upon assessment of these proposals by An Bord Pleanála."

ITEM 5

Committee of the Regions

Councillor Mary Freehill gave an update at the meeting on behalf of the Irish Delegation, on the current work programme of the Committee of the Regions. She outlined that the Delegation will also be making a submission to the Congress of Local and Regional Authorities.

Councillor Freehill also outlined that Sarah Holden has been appointed Administrative Officer for Committee of Regions and Head of the Irish Regions Office in Brussels and she will take up her position next month.

Councillor Fiona O'Loughlin thanked the Irish CoR Support Officer John Crowley for all his work and support who recently left his post.
