#### ITEM 1

#### **Adoption of Minutes**

Minutes of meeting of the Eastern and Midland Regional Assembly held on the 24<sup>th</sup> April 2015 were **APPROVED** and **ADOPTED**.

#### ITEM 2

#### **Enterprise Ireland**

- Presentation by Mick Broughan

Mick Broughan introduced the presentation and outlined the context in relation to the Eastern and Midland Regional Assembly.

#### Mr Broughan outlined:

- Regional Development Plan
- Strategic Pillars
- Agritech

- iLonfar Projects
- The experience economy

A discussion took place on the role of Enterprise Ireland expanding with contributions from Cllrs. Cullen, Fitzpatrick, Fitzgerald, Lacey, McEvoy, Feeney, Cahill, Dooley, Freehill and P.J Reilly.

Mr Broughan responded to questions and the various queries raised.

The Cathaoirleach Cllr. Gerry Horkan thanked Mr Broughan for his presentation and the presentation was noted.

#### ITEM 3

#### **Committee of the Regions Update**

The Director updated the Members on the Committee of the Regions (CoR). Head of Delegation, Cllr Freehill gave an update from the last plenary meeting. She thanked Mr Ronan Gingles for his work and preparations with the plenary. There were two opinions submitted by the delegation. One on Fairtrade and second on Quality of Life. Cllr Freehill stated that Commission President Junker, addressed the COR and he emphasised that there will be no change in the freedom of movement. Cllr Feeney added the next plenary is in July and the main topic under discussion for that plenary will be a regional approach to migration.

#### ITEM 4

#### **Corporate Plan Update**

The Director Mr. Jim Conway informed the Assembly that the first meeting of the Corporate Plan sub-group took place earlier that morning of 12<sup>th</sup> June. The group discussed the main topics that should be included in the corporate plan and these topics were agreed. It was also agreed that both Cllr Healy and Cllr Fitzpatrick will be included in the sub-group and they will be invited also to the next meeting.

#### ITEM 5

#### Correspondence

No correspondence was circulated to the meeting.

#### ITEM 6

#### Any other business

The Cathaoirleach outlined two resolutions to the meeting. First resolution, was to amend the current number of signatories on the EMRA banking accounts. Second, that a business online banking be established for EMRA and that signatories be agreed for the online banking process. Cllr Murphy proposed both resolutions and seconded by Cllr Lacey. Both resolutions were agreed.

Cllr Byrne, asked that the Assembly discuss the issue of Local Authority rates in the region and he outlined that an incentive was necessary for businesses in towns in the region. The Cathaoirleach outlined that amending Local Authority Rates was not a function of the EMRA.

Cllr Freehill proposed that the Assembly write to the Department of Environment, Community and Local Government (DECLG) and request a meeting between the EMRA and the Minister and Secretary General of the DCELG. The correspondence is to express disappointment at the lack of clarity from the Department as to the specific role of Members in the EMRA. Cllr. C Fitzgerald seconded this proposal. The proposal was agreed.

The Designated Chief Executive, Mr Daniel McLoughlin thanked the Assembly during his time involved and he wished the Assembly well into the future. The Cathaoirleach Cllr. Horkan thanked Mr McLoughlin for his work in assisting the Assembly during his time as designated Chief Executive.

Cathaoirleach Cllr. Horkan also thanked the staff for the work done to date in the Assembly.

Mr Jim Conway, Director made a corporate vision presentation, which had been made at the training earlier to the members. The presentation outlined the corporate vision for the Eastern and Midland Regional Assembly.
