ITEM 1

Presentation by EirGrid

Presentation by John Fitzgerald

Mr Fitzgerald introduced EirGrid's Draft Stratey.

- New technology
- North South Interconnector
- National Capital Investment Programme

Following the presentations contributions were made by the following members; Councillors B. Fitzgerald, M. Murphy, T. Cullen, K. Dennison, P. McEvoy and the Cathaoirleach who raised concerns about the North South Interconnector and the effect on land and rural life if overground. Mr Fitzgerald addressed all contributions and concerns and advised that his presentation would be circulated to all members.

ITEM 3 - Planning Items

NTA Transport Strategy for the Greater Dublin Area - briefing by M. Bradley

A presentation was made by Mr Malachy Bradley on the NTA Transport Strategy for the Greater Dublin Area. An overview of the legislative requirement, contents of the strategy, the statutory function of the Regional Assembly and the timelines involved. Mr Bradley indicated that the NTA draft strategy will be on public consultation in the coming days. Also that the Assembly has a specific function in the adoption process of the strategy which most likely will occur at the EMRA meeting in December, according to the current NTA timeframe.

A discussion followed with contributions from Councillors P. McEvoy, D. Lacey, Horkan and Healy in which it was suggested that the Transport Strategy be discussed at the November meeting. Mr Bradley indicated that there will be a number of LECP for discussion at the November meeting, but was willing to present the strategy for discussion. Also it was requested that notification would be sent to Members when the public consultation period commences.
