

Re: Response to the Eastern and Midlands Regional Assembly regarding the Proposed Material Amendments to their Draft Regional Spatial and Economic Strategy

Dear Sirs,

With regard to the proposed material amendments to the Draft RSES, we would like to make the following observations:

## **CHAPTER 5 - DUBLIN MASP**

With reference to Amendment 72 – amendments to **Table 5.1 Strategic Development** Corridors, Capacity Infrastructure and Phasing:-

We note that only some of the areas within the Strategic Corridors reference water and waste water infrastructural upgrades. However, significant water services infrastructure is not mentioned in some areas where it is required e.g. Woodbrook-Shanganagh and Fassaroe. We also note the reference to LIHAF roads and other infrastructure. In a number of cases water services infrastructure is to be delivered in conjunction with these roads. We suggest the amendments listed in Appendix 1 (attached), or a footnote be added to the Table to the effect that "new/upgrades to existing water and waste water services are required in the short to medium term, to service theses strategic corridors, in addition to the strategic water services projects identified in Section 5.5 (Enabling Infrastructure)".

## **CHAPTER 7 – ENVIRONMENT AND CLIMATE**

Reference is made to the Vartry Reservoir under the heading of Amendment No. 9.7 – **Table 7.a Strategic Natural, Cultural and Heritage Assets:**-

We note that the reservoir is a man made structure and not a *Natural* facility as such. We would have concerns regarding any unintentional implications this may have on the management of the reservoir. The EMRA might expand the description or, for example, to say the walks around the reservoir.

## **CHAPTER 10 - INFRASTRUCTURE**

We respectfully submit that the material amendment to the wording in Table 10.1 does not address our concern that no particular beneficiary be singled out. Further, our proposed wording explicitly links the WSP to Strategic Outcome 9 of the NPF, which follows logically from the narrative that precedes Table 10.1 in the Draft RSES.

Arising from the above, we would request that the wording of Table 10.1 be amended in line with our original submission, noted in Appendix 2 attached.

We acknowledge that the Material Amendments include some five new water supply policies. Of these we request that changes are made to New RPO 131 and New RPO 133 as set out in Appendix 2.
