have been clear to suggest to the Minister that it is necessary to initiate the RSES, in the context of the draft NPF. The next round of SPA meetings, scheduled to take place in the coming weeks, may

provide the members the opportunity to consider the NPF and to discuss RSES.

It was AGREED to issue a letter to the Minister regarding the NPF, the upcoming RSES process and

the current legislation.

Mr. Bradly also informed the members that EMRA are procuring the Strategic Environmental

Assessment (incorporating a Regional Level Flood Risk Appraisal) and Appropriate Assessment for

the RSES and once the tender has been awarded this service will commence in the coming months.
